Child-Resistant Vials for Vape Cartridges

16mm and 20mm vial openings with four (4) different heights and CR push down and turn caps:
 16mm 2.7" tall, (16mm 3.33" Coming Mid-August), 20mm 3" tall, and 20mm 3.5" tall



Plastic Jars with Child-Resistant Closures for Flower or Edibles

12+ different sizes & styles from: 1 fl. Oz. jar (holds 1 gram flower) up to 16 fl. Oz. jar (holds 1oz of flower).

Push down & turn child-resistant caps: 20mm, 24mm, 28mm, 33mm, 38mm, 45mm, 53mm, 58mm, 63mm, 70mm & 89mm



Glass Jars with Child-Resistant Closures for Flower or Edibles

Several different jar sizes & styles from: 1 fl. oz. jar (1 gram of flower) up to 16oz 89mm jar (1oz of flower)

Push down & turn child-resistant caps: 20mm, 24mm, 28mm, 33mm, 38mm, 45mm, 53mm, (58mm Coming 8/1/18), 63mm, 70mm & 89mm CRCs
